

**MOTION ON BEHALF OF DILLON ENERGY SERVICES TO RE-OPEN 2021 REPORT YEAR,
PERMIT FILING OF 2021 ANNUAL REPORT, AND WAIVE PENALTY ASSESSMENT**

1. Dillon Energy Services, Inc has been licensed in Ohio as a broker for natural gas and power supply since 2020 (Account 300648293 and Account 300648288).
2. Dillon Energy has not transacted business in Ohio during its period of licensure, but has maintained its status and had filed the required annual reports for the years 2020 and 2022.
3. Dillon Energy did not file its annual report for the year 2021 due to an inadvertent administrative error on the part of Dillon Energy.
4. The Commission has levied assessments of \$1,000.00 each, plus interest, on Account 300648293 and Account 300648288 (which have a Creditor External Account Number of 22-00100606 and 22-00100607).
5. Because the failure to submit an annual report for year 2021, and pay the annual assessment fee, was inadvertent (and, consequently, not intended to avoid compliance obligations), and due to the fact that Dillon Energy did not conduct business in Ohio in year 2021, Dillon Energy respectfully requests the following:
 - (a) That the Commission re-open the report year 2021 for Dillon Energy;
 - (b) That the Commission allow Dillon Energy to submit its annual report for that year, and pay the regular annual assessment; and

- (c) That the Commission waive the penalties and interest assessed for report year 2021 (currently in the total amount of \$1,014.68 each on Account 300648293 and Account 300648288.
