Dynamis has active broker licenses in the following states: OH, IL, CT,NJ, MA,ME, DC, MD, PA, TX, NH, DE and VA. Dynamis has approximately 2,000 electric customers in OH with an annual load of

approximately 102,000 MWh and approximately 1,500 natural gas customers in OH with an annual load of approximately 525,000 dth.

Because Dynamis is a broker and does not supply customers with electric or natural gas, Dynamis presents clients with multiple options from licensed energy suppliers in the state to best fit their needs. The sign up process consists of a signed agreement by the client along with a TPV call. The customer gets a copy of the agreement and terms and conditions, along with rates and terms. Customers are given Dynamis' contact information along with the supplier they contracted with if there are any questions or concerns. Contracted services and billing, etc will come from the energy supplier the customer is contracted through.

Dynamis will do an analysis of the potential customers current bill, provide rates and terms from multiple suppliers and recommend a supplier that best fits the prospective client's needs. Dynamis signs a customer via signature on a contract, completes a TPV and receives a recent copy of their bill. A person from QA reviews all documents and the TPV and if deemed a good sale Dynamis then sends the contract to the correlating energy supplier the deal was signed with. The energy supplier will review the agreement and if deemed OK, will submit that account to the utility and send Dynamis a confirmation. 2024- Ohio Forecasted Financial Statement Summary - Dynamis Energy, LLC

The attached assumptions are based off Dynamis signing up 56 electric commercial deals and getting a 70% attachment rate for natural gas, starting in January of 2024 and fluctuating throughout the year. With an average margin of \$400 per combined customer, that would result in revenue of \$321,915 of new sales for 2024. Dynamis' expenses are approximately 80% of the total margin so net income would be \$64,383 for 2024. Dynamis expects to retain 60-70% of the book of business at normal margins which would result in \$209,245 in total renewal business for 2025. Dynamis would expect at least a 10% increase in net sales in 2025 vs. 2024 with the same percentage of expenses associated with those sales that would result in \$112,670 of net income for 2025 when the renewal business is added to the numbers. These projections and assumptions are based on Ohio electric and gas sales only and don't include other states.






