Enclosed for filing is the Duke Energy Ohio ("Duke") gas cost recovery (GCR) report, as required by Section 4901:1-14, O.A.C., for the month commencing January 2024. This filing is based on supplier tariff rates expected to be in effect on January 2, 2024 and the NYMEX close of December 8, 2023 for the month of January 2024.

Duke's GCR rate effective January 2024 is \$5.586 per MCF, which represents a decrease of \$0.203 per MCF from the current GCR rate in effect for December 2023.
