**AN EMERGENCY RESOLUTION AUTHORIZING THE CLINTON COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR ELECTRIC POWER FOR THE VILLAGE OF SABINA, OHIO.**

WHEREAS, On November 7, 2023 the residents of the Village of Sabina voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers; and,

WHEREAS, The Clinton County Commissioners have offered their services to act on behalf of Village of Sabina in Clinton County as the governmental aggregator; and,

WHEREAS, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation; and

NOW THEREFORE BE IT RESOLVED by the Council of the Village of Sabina, Clinton County, Ohio, with three-fourths of the members elected thereto concurring that:

Section 1. The Village of Sabina Council hereby authorizes the Clinton County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of Village of Sabina, Ohio.

Section 2. This resolution shall be copied to the Clinton County Commissioners, 1850 David Dr. Suite 208 Wilmington, OH 45177



