Resolution Number 23-030

A Resolution Authorizing The Licking County Commissioners to Act as the Purchasing Agent and Governmental Aggregator for Natural Gas Aggregation Program for the Village of Utica, Ohio.

WHEREAS, On November 7, 2023 the residents of the Village of Utica voted in favor of natural gas aggregation to improve purchasing leverage and offer reduced natural gas rates to residential and small business consumers; and,

WHEREAS, The Licking County Commissioners have offered their services to act on behalf of Village of Utica in Licking County as the governmental aggregator; and,

WHEREAS, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of natural gas aggregation; and

BE IT RESOLVED by the Council of the Village of Utica, Ohio that:

Section 1. The Village of Utica Council hereby authorizes the Licking County Commissioners to act as the governmental agent for purchasing and aggregation of natural gas program for the residents of Village of Utica, Ohio.

Section 2. This resolution shall be copied to the Licking County Commissioners, 20 South Second Street, Newark, Ohio 43065.




Section 4. This resolution will take effect upon passage.
