RESOLUTION 23-13

A RESOLUTION AUTHORIZING THE LICKING COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR THE NATURAL GAS AGGREGATION PROGRAM FOR THE VILLAGE OF HEBRON, OHIO.

WHEREAS, on November 7, 2023 the residents of the Village of Hebron, Ohio voted in favor of natural gas aggregation to improve purchasing leverage and offer reduced natural gas rates to residential and small business consumers; and

WHEREAS, the Licking County Commissioners have offered their services to act on behalf of the Village of Hebron, in Licking County as the governmental aggregator; and

WHEREAS, having one centralized aggregator will provide the most expeditious manner to handle any issues arising in the process of natural gas aggregation; and


NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF HEBRON, STATE OF OHIO BY A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1: The Village of Hebron, Ohio by and through Council for the Village of Hebron, Ohio hereby authorized the Licking County Commissioners to act as the governmental agent for the purchasing and aggregation of natural gas for the residents the Village of Hebron, and

Section 2: This resolution shall be certified and copied and provided to the Licking County Commissioners located at 20 South Second Street Newark, Ohio 43055 upon approval, and

Section 3: It is found and determined that all formal actions of this Council concerning and relation to the adoption of this resolution were so adopted in an open meeting of this Council, and that all formal actions were in meetings open to the public, in compliance with all legal requirements.
