**RESOLUTION 2023-20  
VILLAGE OF BUCKEYE LAKE  
FIRST READING**

**A RESOLUTION AUTHORIZING THE LICKING COUNTY COMMISSIONERS TO ACT AS THE PURCHASING AGENT AND GOVERNMENTAL AGGREGATOR FOR ELECTRIC POWER FOR THE VILLAGE OF BUCKEYE LAKE, OHIO.**

WHEREAS, on November 7, 2023 the residents of the Village of Buckeye Lake voted in favor of electric aggregation to improve purchasing leverage and offer reduced electrical generation rates to residential and small business consumers; and,

WHEREAS, The Licking County Commissioners have offered their services to act on behalf of Village of Buckeye Lake in Licking County as the governmental aggregator; and,

WHEREAS, having one centralized aggregator will provide for the most expeditious manner to handle any issues arising in the process of electrical aggregation.

BE IT RESOLVED by the Council of the Village of Buckeye Lake, County of Licking, State of Ohio, that:

SECTION I: The Village of Buckeye Lake Council hereby authorizes the Licking County Commissioners to act as the governmental agent for purchasing and aggregation of electric power for the residents of Village of Buckeye Lake, Ohio.

SECTION II: This resolution shall be copied to the Licking County Commissioners, 20 South Second Street, Newark, Ohio 43065.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the adoption of this resolution were so adopted in an open meeting of this Council, and that all formal actions, were in meetings open to the public, in compliance will all legal requirements
