Application Experience and Plan Description: As the founder of this entity, we've been for 12 years, and my personal experience in the deregulation industry is 17 years. In those 17 years, my time was spent predominantly between IL and OH and all Utilities servicing the PJM Grid. For the last 7 years, we've been more involved in TX, and the ERCOT grid, as well as expand into other markets like MD, PA, and NJ. Our focus has been electricity with our niche being hospitality (hotels + restaurants). A bulk of their heating is an electric load, so their natural gas



bills have normally been relatively low. Regarding natural gas, we've only been marketing natural gas since 2019, and work strictly with commercial clients in hospitality. Between the 6 states, we're active in, we're currently managing nearly 900 commercial accounts for the electric, and still maybe only a dozen with natural gas. On the electric, our average hotel is using 550,000 annual kWhs and the average restaurant is using 150,000 annual kWhs with more than 50% of our clients being hotels.

Our plan to grow and expand our natural gas book of business. Most of our commercial clients on the electric have been on the local default utilities plan (ie: Centerpoint, Duke, Dominion, Columbia Gas, etc) for years, so being able to analyze that data and provide year over year trends with a weighted-average-rate breakdown we do for our electric clients have and will continue to open up some doors on the natural gas side of the business. Especially with many of our customers experiencing really high natural gas rates in 2021 and 2022, some of the low natural gas rates we're seeing now really put the market and potential savings into perspective with our customers.

When it comes to executing natural gas contracts, we use DocuSign for nearly 99% of our agreements, and billing is provided directly by the winning supplier in our NG-RFP. When it comes to responding to customer inquiries and complaints, we have a 4-person operations support team that is on call for any inquiries, or complaints. Additionally, have a dedicated line for customer service at (312) 520 - 4220 and want to ensure 100% of our clients that we're available for any request of, or pertaining to their natural gas needs.

Operations Description: The operational nature of TMGES, INC., d/b/a Ananta Energy Source is predominantly catering to our clients and their energy procurement needs. Many of our clients are in hospitality (hotels + restaurants), so they're typically trying to procure electricity first, which we've successfully been doing in Ohio for almost 12 years. Our operations has been processing more and more bids in Ohio the last 3-4 months, and with the uptick, we've been able to analyze 12-24 months worth of NG HUD compiling weighted-average-rate analysis for our hospitality clients and procuring some NG agreements along the way. Currently, our Operations team is not involved with the scheduling of the retail NG for deliver, and/or involved with the provision of retail ancillary services. Our operations assists in the contracting process between our commercial clients and Natural Gas suppliers.

They also assist heavily for any customer service related concerns from customers, and assist with commission inquiries in a timely manner.





Assumptions

- 1. TMGES, INC., d/b/a Ananta Energy Source is currently working on 2023 accounting and closing out the books, so the following assumptions are based on the Current Year being 2022, since 2022 has been closed out and taxes were filed.
- Total natural gas sales in Ohio for the year 2022 are estimated to be \$18,325.49, which is approximately 5% of our Total Energy Sales volume (\$357,545.69) between the markets we are active in outside of Ohio (ie: IL, TX, MD, PA, etc).
- 3. We are predicting natural gas sales in Ohio for forecast YR 1 (2023) and YR 2 (2024) to increase by 25% due to the increased demand we are seeing from current clients and new opportunities.
- 4. Understanding 5% of our total sales were Ohio Natural Gas, we can estimate that 2% of our total expenses were dedicated towards Ohio Natural Gas marketing and management. Hence, our expenses related to Ohio natural gas procurement in our current year ending 2022 are estimated to be \$10,666.47. Most of our efforts were focused on electricity for the current year 2022. We're scaling back the next year (2023) by reducing overhead from both marketing and labor, which should provide for a 25% reduction in expenses for 2023 and 2024 should be almost identical to 2023.
