#### FINDING AND ORDER

#### I. SUMMARY

**{¶ 1}** The Commission finds that Certificate No. 13-SPV-OH-GATS-0340 should be revoked, and this case should be dismissed and closed of record.

#### II. DISCUSSION

**{¶ 2}** On April 8, 2013, Barbra Gant (Applicant) filed an application for certification of a renewable energy resource generating facility (Facility) located at 10682 Township Road 29, East Liberty, Ohio 43319. According to the application, the Facility is a roof mounted solar photovoltaic system.

**{¶ 3}** Ohio Adm.Code 4901:1-40-04(D)(2) provides for automatic approval of an application for certification as an eligible Ohio renewable energy resource generating facility, unless suspended by the Commission.

**{¶ 4}** The application was automatically approved, and the Facility was issued Certificate No. 13-SPV-OH-GATS-0340 on June 10, 2013.

**{¶ 5}** On January 8, 2024, Staff filed a letter on behalf of Applicant requesting that the Commission revoke Certificate 13-SPV-OH-GATS-0340, as the Facility was destroyed by a fire.

**{¶ 6}** The Commission finds the Applicant's request to revoke Certificate No. 13-SPV-OH-GATS-0340 is reasonable and should be granted.

### III. ORDER

{¶ 7} It is, therefore,

**{¶ 8}** ORDERED, That Applicant's request to revoke the Certificate 13-SPV-OH-GATS-0340 be granted. It is, further,

{¶ 9} ORDERED, That Case No. 13-842-EL-REN be dismissed and closed of record. It is, further,

**{¶ 10}** ORDERED, That a copy of this Finding and Order be served upon all parties of record.
