This letter is intended as a formal Request for Extension of the project due date.

This request for extension of the scheduled due date ordered for this project.

This request for extension is based on the Patriot Rail acquisition of the former Pioneer Lines Railroad Properties, including the Michigan Southern Railroad Company (dba Napoleon, Defiance and Western Railway) (NDWR). The NDWR and Patriot Rail are still transitioning project information, and processes attributed to this acquisition, but are committed to the working partnership with PUCO.

The original PUCO order for this project was issued dated December 14, 2022, with a completion due date of December 14, 2023. While during this time the NDWR and PUCO corresponded on the exact scope and configuration determination for the project, which has now been resolved. The NDWR is requesting this extension to allow for the immediate assignment to our Contractor and the re-design of the circuit plans per the revised scope and material requisition and installation.

The NDWR realizes that the PUCO ordered due date of 12/14/2023 has expired, and we confirm receipt of the PUCO letter advising NDWR of "Failure to Complete Project as Ordered by project deadline" dated 01/17/2024. This response letter is intended to rectify the NDWR failure to request this extension in a timely manner.

The NDWR is respectfully requesting an 8 month extension of the due date to **August 31, 2024** to allow NDWR to complete the ordered work. It is expected that this requested extension due date will provide sufficient time for the awarded Contractor to requisition and obtain materials to complete the project as ordered by PUCO.
