Enclosed are Ohio Power Company's updated tariff for the Pilot Throughout Balancing Adjustment Rider. Per Staff's recommendation in this docket, the Company has been working with Staff to move any remaining balances to a similarly structured non-bypassable rider, then make a filing with the Commission proposing the same. For now, this tariff is being adjusted to zero for OP GS-1 customers as the class costs are fully recovered. We expect that the final remaining rate will be zeroed out later this year. The Company will also update this tariff in the TRF docket that was previously filed electronically with the Commission's Docketing Division.
