- (CA) Individual Season Pass each ADULT, *age seventeen (17) and older* for Unlimited travel to be used between Put-in-Bay and Kelleys Island **(May 24 – September 8)**. .... **\$325.00**
- (A) Individual Season Pass each child, *age twelve (12) to sixteen (16)*, for Unlimited travel to be used between Put-in-Bay and Kelleys Island WITH THE PURCHASE OF AN ADULT SEASON PASS.....**\$245.00**
- (A) Individual Season Pass each child, *age six (6) to eleven (11)*, for Unlimited Travel to be used between Put-in-Bay and Kelleys Island WITH THE PURCHASE OF AN ADULT SEASON PASS.....**\$105.00**
  - One way each parcel weighing thirty-five (35) pounds or less unaccompanied by a passenger.....\$10.00
- (CA) One way each person commuter ticket under an individual minimum purchase requirement of twenty (20) tickets, which must be purchased at the Put-in-Bay ticket office. **(Minimum \$280.00)** .....**\$14.00**

### TICKETS

- Tickets are issued when fares are paid in cash. Boarding passes are accepted at vessel just prior to boarding.

### SEASON

- (C) The water transportation season during which Put-in-Bay Boat Line Company Operates, commences approximately **May 24** and ends approximately **September 8, 2024**.

### BAGGAGE

- Each passenger is allowed 100 lbs. of baggage, and no charge is made, therefore. Baggage must be of the size, which may be safely stowed below the passenger's seat.
- Put-in-Bay Boat Line Company is a water transportation company subject to the *supervision of the Public Utilities Commission of Ohio*. Complaints regarding the charges or service of Jet Express should first be directed to the company at the number listed above.
