On June 27, 2023, as supplemented on January 8, 2024, Prairie Flyer Energy Storage LLC (“Applicant”) filed an application with the Ohio Power Siting Board (“Board”) proposing to construct a battery energy storage system facility in the City of Vandalia, Montgomery County, Ohio.

The Board’s Staff filed its Staff Report of Investigation (“Staff Report”) on January 26, 2024. By entry issued November 21, 2023 the Board established the procedural schedule in this matter and directed parties to file, by February 16, 2024, their list of issues about which they may be interested in pursuing cross-examination of witnesses at the evidentiary hearing. Upon review of the Staff Report, the Applicant notes that it does not at this time have any issues that it wishes to cross examine Staff witnesses on with regard to the Staff Report.
