Errors Under "Reco" Found In Violations Of 4905.26 That Are:

- a. charge is in any respect unjust(Over Charging)
- b. service is in any respect unjust(Forcing An Unneeded Smart Meter)
- c. service rendered is in any respect unjust(Making People Pay Cost Of Business Expenses The Company Was Well Aware Of When Starting The Business for 80+ years)
- d. demanded is in any respect unjust(Puco Can Reverse Any Decision It Has Made After Facts Are Shown,Or Give No Respect To Prier Decisions)
- e. that any service is, or will be, inadequate or cannot be obtained (Precluded By Contract)

### Bv:

- 1) Larry Opted Out Once And Was Not Told Of A Fee When Doing So.
- 2) Aep In 2021 Silently Raised Larry's Bill To 72.00, In 2022 Aep Then Started Demanding Payments By Letter, Forum, Calls With Threats Of Service Termination that was Outside PIPP Agreement.
- 3) Aep Made A Business For 80+ Years Now Trying To Make A Customers Responsibility For What Aep Willfully Did In 2009 With Larry (Equatable Estoppel). (Also Sec 4) Below)
- 4) Aep Ran To Puco Before Even TRYING to Talk To Larry To Come To An Agreement Both Would Be Okay With & Trying To Use Puco To Avoid Enforcing Contracts With Customers To Check Meters At Aep's Expense With False Claims Of The Smart Meter Being Better, Larry Is Showing Also That The Normal Meters Was NOT Pass "End Of Life"e Usage And Now Are Probably In Land Fills Showing Smart Meters Has Made More Waste & Was Not Needed Other Than To Allow AEP to Create A New Way To Make People Pay For What Aep Agreed To Do To Get The People As Customers (Equatable Estoppel).
- 5) Aep Over Charges, Time Line Does NOT Match Bills, Bills However Reflect Larry Was On PIPP Payments In 2017, 2018, 2019, 2020, 2021, 2022, 2023, 2024 When Agreeing With PIPP For 46.00 Aep Waived The Smart Meter Fee Every Year, Larry Allowed PIP To Speak For Larry.
- 8) Aep Gave No Notice When Silently Raising Larry's Agreed 46.00 Bill To 72.00 In 2021 But Did Try To Get Larry to "Re-Opt Out" In 2022 Many Times But Was Told "I Opted Out Once With Out Being Told Of A Fee And Will Not Re-Opt Out".
- 9 Aep Accepted PIPP Again In 2021 To 2024 Yet Keep Larry's Bill Well Pass The Agreed PIPP Payment Of 46.00 To 72.00 OVER Charging Larry.

It Has Come To Larry's Attrition That AEP Has Refused PIPP, Larry Was Informed By AEP That Larry Is No Longer On PIPP. When Asking AEP Has Tried A "Word Salad" Again.

According To AEP Larry Violated The PIPP Agreement Of Two Payments Of 40.00,44.00 And Not 46.00,AEP Was More Than Happy To Tell Larry About "How Larry Is Wrong" But When Pressed With PUCO Rules About Paying "What Is Fair" AEP Started Hiding Behind "You Cannot Talk To Us About These Issues And Must Go To PUCO Or Talk With YOUR Lawyer" Further Stating "This Is Not AEP But A Issue With You And PIPP".

AEP Seems To Disagree And Terminated Larry's PIPP "Themselves" Overriding PIPP Stating Larry Has A Deal With PIPP Of 46.00.

Larry States This Violated Again Errors Under "Reco" Found In Violations Of 4905.26

That Are:

- a. charge is in any respect unjust(Violating PUCO Rules Of Payment While In Conflict)
- b. service is in any respect unjust(Violating PUCO Rules Of Payment While In Conflict)
- c. service rendered is in any respect unjust(Violating PUCO Rules Of Payment While In Conflict)
- d. demanded is in any respect unjust(Violating PUCO Rules Of Payment While In Conflict)
- e. that any service is, or will be, inadequate or cannot be obtained (Larry Who Is On Disability Pay Over 2 To 3 Thousand Dollars In One Payment)

Forcing Larry To Pay The Total Amount Of \$2,666,36 (Jan 9<sup>th</sup>,2024) To Now \$3,225.28(Feb 20<sup>th</sup>,2024) Knowing There Is No Way Larry Could Pay Forcing Larry to:

- 1) Have Electric Disconnected Until Larry Is Able To Pay Full Amount Bypassing PIPP And Puco Rules. (See Exhibit 2 New DEMAND for Full Payment Of \$3,225.28 By 3/11/2024)
- 2) Force Larry To Reapply With PIPP Where As Aep Can then Try To Change The Agreement Against Already Verified Agreement And Bypass Puco Decisions Pending And Pipp Agreement And Puco's Rules.
- 3) Have Larry's home found unlivable for not having Electric, forcing Larry To Abandon the home.
- 4) Cause Larry to freeze in the cold by having No electric to run the furnace (see above 3) as well.
