## ENTRY

Entered in the Journal on March 13, 2024

{¶ 1} Pursuant to R.C. 4905.10, by Entry issued January 26, 2022, the Commission directed all regulated entities to file a 2021 annual report for fiscal assessment through the PUCO Community, the Commission's web-based filing system, by April 29, 2022. The Commission uses the annual report information to generate invoices that are then sent to the annual report filers on or before the first day of October consistent with R.C. 4905.10(B) to fund the operations of the Commission.

{¶ 2} On March 5, 2024, EcoPlus Power, LLC (EcoPlus) filed a motion for leave to late file its annual report for calendar year 2021. EcoPlus states that it has been a licensed competitive retail electricity supply service pursuant to Certificate No. 21-059896E. EcoPlus submitted its Annual Report for Fiscal Assessment for calendar year 2021. It has since been discovered that through inadvertent data entry error, the sales volumes reported in its Annual Report for 2021 contained incorrect data. As a result, EcoPlus requests leave to amend its 2021 Annual Report to correct the sales volumes and revenues. Upon approval of this motion and the unlocking of the 2021 annual report in the PUCO Community, EcoPlus commits to submit promptly its 2021 Annual Report.

{¶ 3} The attorney examiner determines that EcoPlus's motion for leave to file its amended annual report for calendar year 2021 should be granted. EcoPlus must now contact the Commission's Fiscal Division to make arrangements to submit its 2021 Annual Report for Fiscal Assessment and to pay any applicable fees.

{¶ 4} It is, therefore,

{¶ 5} ORDERED, That the motion filed by EcoPlus be granted in accordance with Paragraph 3. It is, further,

{¶ 6} ORDERED, That a copy of this Entry be served upon EcoPlus.
