{¶ 1} On March 12, 2024, Ohio Energy Consultants (Applicant) filed a renewal application for certification as a competitive retail natural gas service (CRNGS) provider in Ohio in Case No. 17-355-GA-AGG. More specifically, Applicant seeks renewal of its certification as a retail natural gas broker.

{¶ 2} On the same day, Applicant also filed a renewal application for certification as a competitive retail electric service (CRES) provider in Ohio in Case No. 17-366-EL-AGG. With this application, Applicant seeks renewal of its certification to provide power broker services.

{¶ 3} Pursuant to R.C. 4928.08 and Ohio Adm.Code 4901:1-24-10, Applicant's CRES application is subject to a 30-day automatic approval process. Similarly, pursuant to R.C. 4929.20 and Ohio Adm.Code 4901:1-27-10, Applicant's CRNGS application is subject to a 30-day automatic approval process. Both Ohio Adm.Code 4901:1-24-10 and Ohio Adm.Code 4901:1-27-10 further provide that, upon good cause shown, the Commission or an attorney examiner may suspend consideration of a CRES or CRNGS application, respectively. *See also* R.C. 4928.08 and R.C. 4929.20.

{¶ 4} The attorney examiner finds that, to allow for further review of these matters by the Commission and Staff, good cause exists to suspend the 30-day automatic approval process with respect to Applicant's renewal applications for certification as a CRES and CRNGS provider in the state of Ohio.

{¶ 5} It is, therefore,

{¶ 6} ORDERED, That the automatic approval process for Applicant's renewal application for certification as a CRNGS provider, filed in Case No. 17-335-GA-AGG, be suspended until further ordered by the Commission. It is, further,

{¶ 7} ORDERED, That the automatic approval process for Applicant's renewal application for certification as a CRES provider, filed in Case No. 17-336-EL-AGG, be suspended until further ordered by the Commission. It is, further,

{¶ 8} ORDERED, That a copy of this Entry be served upon all parties of record.
