Dear Ms. Troupe:

On March 18, 2024, a Change in Operation notice for AT&T Corp. was filed with the Public Utilities Commission of Ohio. AT&T Corp.'s notice included Exhibit B (proposed tariff sheets) for AT&T Enterprises, LLC. Exhibit B included Exhibit B-1 AT&T Enterprises, LLC - PUCO No. 1 Access Services and Network Interconnection Services and Exhibit B-2 AT&T Enterprises, LLC - PUCO No. 2 Local Exchange Services.

With this submission, AT&T withdraws the Exhibit B-1 and Exhibit B-2 submitted on March 18, 2024, and replaces it with Exhibit B-1 and Exhibit B-2 attached with this submission.

On May 1, 2024, AT&T Corp. will merge with and into AT&T Enterprises, Inc., a Delaware corporation, and shortly after on May 2, 2024, AT&T Enterprises, Inc. will convert to a Delaware limited liability company named AT&T Enterprises, LLC.

AT&T Enterprises, Inc. will offer and provide services with the attached tariff until the Ohio Secretary of State processes the request to update AT&T Enterprises, Inc.'s registration with its new name AT&T Enterprises, LLC (which will be filed soon after the change takes place in Delaware). Shortly after this takes place, AT&T Enterprises, Inc. will supplement Exhibit B with the same tariffs reflecting its change of name to AT&T Enterprises, LLC.
