





Section 4923.99, Ohio Revised Code (ORC) authorizes the Public Utilities Commission of Ohio to assess civil forfeiture up to \$25,000 for each day of each violation. The amount of any forfeiture is dependent upon the nature, gravity, circumstances, and extent of the violation, the offender's degree of culpability for the violation, and the offender's violation history. "Total Amount Due" is the total amount of the civil forfeiture assessed for all violations described in this notice.


### **Potential Disqualification**

The BMV may disqualify you from operating a commercial motor vehicle for a minimum of 60 days. Any BMV sanction is <u>in addition to</u> sanctions imposed by the PUCO.
