Enclosed for filing is the Duke Energy Ohio (“Duke”) gas cost recovery (GCR) report, as required by Section 4901:1-14, O.A.C., for the month commencing July 2024. This filing is based on supplier tariff rates expected to be in effect on July 1, 2024 and the NYMEX close of June 6, 2024 for the month of July 2024.

Duke’s GCR rate effective July 2024 is \$6.842 per MCF, which represents an increase of \$0.388 per MCF from the current GCR rate in effect for June 2024.
