Enclosed for filing is the Duke Energy Ohio (“Duke”) gas cost recovery (GCR) report, as required by Section 4901:1-14, O.A.C., for the month commencing August 2024. This filing is based on supplier tariff rates expected to be in effect on August 1, 2024 and the NYMEX close of July 9, 2024 for the month of August 2024.

Duke’s GCR rate effective August 2024 is \$6.458 per MCF, which represents a decrease of \$0.384 per MCF from the current GCR rate in effect for July 2024.
