**STARK SOLAR, LLC’S

On February 28, 2024, Stark Solar, LLC (“Applicant”) filed an application with the Ohio Power Siting Board (“Board”) proposing to construct a solar-powered electric generation facility in Stark County, Ohio.

The Board’s Staff filed its Staff Report of Investigation (“Staff Report”) on July 22, 2024. By entry issued May 31, 2024, the Board established the procedural schedule in this matter and directed parties to file, by August 20, 2024, their list of issues about which they may be interested in pursuing cross-examination of witnesses at the evidentiary hearing. Upon review of the Staff Report, the Applicant notes that, at this time, it has no issues related to the conditions recommended in the Staff Report upon which it will be cross-examining the Board’s Staff. The Applicant would be interested in cross-examining the Board’s Staff regarding the facility serving the public interest, convenience, and necessity in accordance with Ohio Revised Code Section 4906.10(A)(6).

The Applicant, by providing this list, is not waiving its right to address other issues and reserves its right to include additional issues upon cross-examination.
