

STATEMENT OF COMPLIANCE

In compliance with the Public Utilities Commission of Ohio Entry dated June 29, 2000, GTE North Incorporated affirms that its intrastate access rates are set at levels equal to those in effect on June 30, 2000. Pursuant to that Entry, these rates shall remain in effect until the Commission issues a decision in PUCO Case No. 00-127-TP-COI or December 1, 2000, whichever occurs first. Furthermore, GTE North Incorporated acknowledges that it is obligated to implement the \$5 million intrastate access reduction mandated in PUCO Case No. 98-1398-TP-AMT. Pursuant to the requirements of that case, GTE North Incorporated submitted its plan to achieve the required reduction to the Commission on May 9, 2000. GTE North Incorporated will implement that proposed reduction upon Commission approval.

25 we'll conclude this hearing at this time and the


public hearing is adjourned. Thank you for coming.
