On July 1, 2002 Cincinnati Bell Telephone Company (CBT) filed an application to revise its **General Exchange Tariff PUCO No. 8** to conduct a promotion on Business Complete Connections service. This promotion offered business customers who subscribed to Business Complete Connections service during the promotional period a waiver of the nonrecurring charge. This promotion is scheduled to end December 31, 2003.

With this application CBT is requesting permission to revise the **Business Complete Connections promotion to include the new business package that was added to the Complete Connections tariff on July 25, 2003.** Customers purchasing the new Business Complete Connections/ADSL Package will also receive a waiver of the \$10.00 nonrecurring charge.
