- (1) By Entry of September 21, 2004, Case Nos. 04-596-RR-CSS, 04-598-RR-CSS, 04-1061-RR-CSS, 04-1081-RR-CSS, 04-1082-RR-CSS, 04-1163-RR-CSS, 04-1164-RR-CSS, 04-1219-RR-CSS, and 04-1288-RR-CSS, involving complaints that CSX Transportation (CSX) failed to eliminate excessive vegetation on its property, were scheduled for hearing on October 27, 2004, at 10:00 a.m., in Hearing Room 11-F, at the offices of the Commission, 180 East Broad Street, Columbus, Ohio 43215.
