OBJECTIONS TO AMERITECH OHIO'S FILINGS**


AT&T Communications of Ohio, Inc. ("AT&T"), by its undersigned attorneys hereby withdraws its April 1, 1996 Objections and its May 6, 1996 Supplemental Objections to the above-captioned filings of Ameritech Ohio. This withdrawal is being filed pursuant to the terms of that certain Settlement Agreement entered into by and among the P.U.C.O. and its staff, Ameritech Ohio, Time Warner AxS of Ohio, L.P., Time Warner Communications of Ohio, L.P.,

the Office of the Ohio Consumers' Counsel, AT&T, Sprint Communications Company L.P., MCI Telecommunications Corporation and the Ohio Cable Telecommunications Association, which was approved by this Commission in Case No. 96-532-TP-UNC. As further agreed in the Settlement Agreement, AT&T is not withdrawing its Memorandum Contra to Ameritech Ohio's Motion for Protective Order in Case Nos. 96-389-TP-AEC, 96-390-TP-AEC and 96-403-TP-AEC, and continues to assert that Ameritech Ohio's Motion for Protective Order should be denied.
