Attached is Cincinnati Bell Telephone Company's (CBT's) tariff filing to revise its **Out of Territory Services Tariff**, PUCO No. 1, Section 5, **reduce the monthly rates for Asymmetrical Digital Subscriber Line Service (ADSL) HyperSpeed and Direct ADSL for residential customers.**

Pursuant to the Finding and Order in Case No 99-1496-TP-UNC, CBT's Commitment 2000 Plan (Case No. 96-899-TP-ALT) is applicable for CBT's operations outside of its existing territory. Therefore, pursuant to Section VI.F.7. of CBT's *Commitment 2000 Plan*, this filing is scheduled to become effective upon public filing. Attached is the tariff page bearing the 96-899-TP-ALT case number in order to implement the price change. All of the terms necessary to implement the price change for existing services as detailed in *Commitment 2000 Plan* have been met.

The ADSL services vary according to the combination of "downstream" and "upstream" speeds. The monthly rates associated with each service applies to ADSL, as it appears in this tariff, and are in addition to the rates that are applicable to all other services, equipment and facilities that are needed for ADSL. The higher education rate is available to students, faculty and staff associated with higher educational institutions as described in paragraph 5.18.3.10.
