ENTRY

The attorney examiner finds:

- (1) This application was filed on May 3, 1996, by Preferred Carrier Services, Inc. (PCS or applicant).
- (2) By entry issued on March 3, 1997, the application was approved but was partially suspended pending a review of the applicant's tariff. Despite at least three entries warning applicant to move forward with tariff revisions requested by Commission staff or face dismissal of the application, PCS's tariff remains uncompleted.
- (3) PCS should file any requested revisions to its tariff by March 17, 2003, or the attorney examiner will recommend to the Commission that this case be dismissed for lack of prosecution. Because of the length of time this application has been pending, the attorney examiner will grant no further extensions of time to complete the tariff filing.

It is, therefore,

ORDERED, That the applicant move forward with this case in accordance with Finding (3) by March 17, 2003, or this case will be recommended for dismissal. It is, further,

ORDERED, That a copy of this entry be served upon the applicant by certified and by regular United States ordinary mail. It is, further,

ORDERED, That a copy of this entry be served upon any interested party of record by ordinary mail.
