GENERAL REGULATIONS

9. SPECIAL PROMOTIONS

- 9.01. GTE North Incorporated will offer the following ongoing promotion, to go into effect on February 26, 1994 and continue for an indeterminate period.

A Money Back Guarantee will apply for Custom Calling Services. The customer must first agree to subscribe to the relevant service(s) at the applicable monthly rate(s). If the customer notifies the Company that he is not satisfied with the service(s) provided, he will be entitled to a full refund of one (1) month's Monthly Recurring Charge or portion thereof if subscription is less than 30 days. This refund will be applied as a credit on the customer's bill. Each customer will be entitled to the credit one time per service.

- 9.02. GTE North Incorporated (GTE) will offer the following promotion, to be in effect from January 4, 1999 to April 4, 1999, to its residential customers. (N)

During the period from January 4, 1999 through April 4, 1999, GTE will waive the first month's recurring rate when a Residence customer not currently subscribing to Call Waiting elects to purchase this service. The waived charge is normally \$2.50 per line, as shown in Section 3 of this Tariff. (This offer is not available to Residence customers who currently subscribe to Call Waiting.) (N)
