Dear Ms. Crockron:

On July 1, 2002, Cincinnati Bell Telephone Company (CBT) filed an application to revise its **General Exchange Tariff PUCO No. 8** to provide a special promotion of its **Asymmetrical Digital Subscriber Line Service (ADSL) TurboSpeed** package. **Residential** customers who subscribe to ADSL TurboSpeed Service would be eligible to receive a **50% discount off the first three months' recurring charges** associated with ADSL. This special promotion was available beginning July 1, 2002 through July 31, 2002.

With this filing, CBT would now like to request permission to **extend the end date to August 11, 2002**. All of the terms and conditions relating to this promotion, which were established with the July 1, 2002 filing, will continue to apply.
