The Commission finds:

- (1) On December 19, 2002, the Commission issued its order in this proceeding directing Columbia Gas of Ohio, Inc. (COH), among other items, to amend its tariffs to provide for periodic actual readings of meters on at least an annual basis.
- (2) On January 17, 2003, COH submitted for Commission review and approval proposed new tariff provisions.
- (3) The Commission has reviewed the proposed tariff and finds it should be approved.

It is, therefore,


ORDERED, That the company is authorized to file in final form, four complete, printed copies of the tariffs consistent with the findings of this entry and to cancel and withdraw the superseded tariffs. One copy shall be filed in this case, one copy shall be filed in the company's TRF docket, and the remaining two copies shall be designated for distribution to Commission staff. It is, further,

ORDERED, That nothing in this entry shall be binding upon this Commission in any future proceeding or investigation involving the justness or reasonableness of any rate, charge, rule or regulation. It is, further,




