ENTRY

The Commission finds:

- (1) On December 6, 2001, the Commission issued an opinion and order in this matter that adopted revised rules for competitive telecommunication services pursuant to Chapter 4927, Revised Code. On November 21, 2002, January 16, 2003, February 13, 2003, and March 6, 2003, the Commission issued entries on rehearing ruling on the additional applications for rehearing filed in this matter.
- (2) Pursuant to Section 111.15, Revised Code, copies of the adopted rules, Rules 4901:1-6-01 through 4901:1-6-24, have been filed with the Joint Committee on Agency Rule Review, the Legislative Service Commission, and the Secretary of State. In accordance with Section 111.15(B)(1), Revised Code, the aforementioned rules shall become effective on April 7, 2003. Unless otherwise determined by this Commission, all telephone companies shall comply with the pertinent provisions of newly adopted Rules 4901:1-6-01 through 4901:1-6-24 on April 7, 2003. Telephone companies eligible to file cases under Chapter 4901:1-6, beginning April 7, 2003, should utilize the updated application and service requirements forms available from the Commission's website.
- (3) In our March 6, 2003, entry on rehearing, the Commission announced that, in the near future, we were going to open a new docket in order to, among other things, solicit further comments on the service parameters for secured inmate facility services. Until such time as the Commission completes further consideration of the aforementioned issues in a separate docket, the Commission is, on our own motion, suspending the applicability of the secured inmate facility provisions found in Rule 4901:1-6-23(C). During suspension of Rule 4901:1-6-23(C), telephone companies must continue to adhere to the secured

inmate facility standards set forth in the appendix attached to the February 27, 1992 Entry on Rehearing in Case No. 88-560-TP-COL

Also during the pendency of this further investigation, SBC Ohio may continue to charge its previously approved rate of \$2.75 for the operator-handled portion of calls from secured inmate facilities as set forth in finding 6 of the March 6, 2003 entry on rehearing in this docket. Further, during the pendency of this separate investigation, consistent with Rule 4901:1-6-23(E), SBC Ohio and Sprint may not increase any secured inmate facility rates without first filing a tariff application with the Commission. Such application shall not be subject to an automatic approval timeframe.

(4)In the November 21, 2002, entry on rehearing, the Commission determined that all switchless rebiller applicants must obtain certification in order to provide regulated telecommunication services in Ohio after March 1, 2003. Prospective switchless rebiller applicants must obtain a certificate of public convenience and necessity by filing for certification under the provisions of Rule 4901:1-6-09. Additionally, the November 21, 2002, entry on rehearing found that those switchless rebillers heretofore operating pursuant to the provisions of Case No. 89-563-TP-COI (89-563), In the Matter of the Commission Investigation Into Implementation of Sections 4927.01 Through 4927.05, Revised Code, as They Relate to Competitive Telecommunication Services, would be contacted by subsequent entry and afforded an opportunity to obtain certification. Attached as Appendix A is a list of all of the switchless rebiller applicants and their associated case numbers that have filed with the Commission under the auspices of 89-563. A copy of this entry shall be mailed to each of the entities listed in Appendix A by our Docketing Division. Those entities listed in Appendix A that desire to continue providing intrastate telecommunication services must file a certification application under Rule 4901:1-6-09, by June 3, 2003. Those switchless rebillers that fail to seek certification during this certification window will lose their authority to provide intrastate telecommunication services on July 3, 2003. Further, we direct our Docketing Division to close all open and/or suspended CT-RRJ cases listed in Appendix A on July 3, 2003.

It is, therefore,

ORDERED, That the effective date of Chapter 4901:1-6 will be April 7, 2003. It is, further,

ORDERED, That the provisions of Rule 4901:1-6-23(C) addressing secured inmate facilities are suspended sua sponte in accordance with finding 3. It is, further,

ORDERED, That SBC Ohio and Sprint/United comply with finding 3. It is, further,

ORDERED, That all entities operating as switchless rebillers must comply with finding 4. It is, further,

ORDERED, That the Docketing Division close all CT-RRJ applications on July 3, 2003, in accordance with finding 4. It is, further,

ORDERED, That a copy of this entry be served upon all certified telephone companies operating in Ohio, all switchless rebillers set forth in Appendix A, all commercial mobile radio service providers operating in Ohio, and all other interested persons of record.
