ENTRY

The Commission finds:

- (1) On December 30, 1994, in Case No. 94-2044-TR-AIC, January 5, 1995, in Case No. 95-5-TR-AIC, and on January 24, 1995, in Case No. 95-81-TR-AIC, Aberdeen Express, Inc. and Sydney Truck & Storage, Inc. filed applications to establish irregular route rate concurrence with other Commission regulated motor carriers. Historically, this type of application was filed by motor carriers to set rates for joint hauling operations. As part of this type of application and once approved by the Commission, each applicant was required to publish the approved concurrence with the Ohio Motor Freight Tariff Committee, Inc. (Tariff Committee).
- (2) On August 8, 1994, President Clinton signed into law the Federal Aviation Administration Authorization Act of 1994 (the 1994 Act), which preempted all states from regulating any price, route, or service with respect to the transportation of property in intrastate commerce. As a result of the 1994 Act, the above-captioned applications no longer need Commission approval nor does the Commission approved concurrence need to be filed with the Tariff Committee. Accordingly, these applications should be dismissed and these cases closed of record.




