

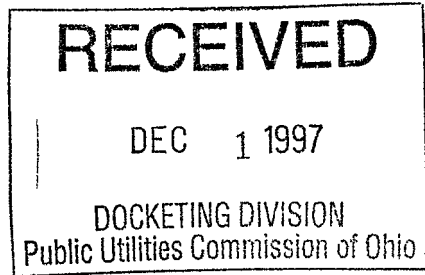


AT&T shall also make available for deposition each person who submits prefiled testimony for consideration by the Commission in this proceeding.
