

Air Liquide America Corporation ("Air Liquide") hereby respectfully notifies the Public Utilities Commission of Ohio ("Commission") that it is withdrawing from this proceeding. On November 23, 2005, Air Liquide filed a motion to intervene pursuant to Section 4903.221, Revised Code, and Rule 4901-1-11, Ohio Administrative Code. On December 8, 2005, Toledo Edison filed a Memorandum Contra Air Liquide's Motion to Intervene. Air Liquide's intervention request has not been acted upon. Thus, Air Liquide's withdrawal has no affect upon the record as it currently stands or the Commission's ability to consider the relief requested by the applicants.


