On October 24, 2000, Cincinnati Bell Telephone Company (CBT) filed a tariff filing to revise its General Exchange Tariff PUCO No. 8 to provide a special promotion of the Call Forwarding Busy, Call Forwarding Don't Answer, and Message Waiting Indicator Services, and the Voice Mail Support Package (Call Forwarding Busy, Call Forwarding Don't Answer, and Message Waiting Indicator Services).

Residential customers, who order Call Forwarding Busy, Call Forwarding Don't Answer, Message Waiting Indicator Services, or the Voice Mail Support Package, will receive a waiver of the nonrecurring charge of \$6.50 associated with these services. This special promotion was to have been in effect from October 27, 2000 through November 30, 2000. CBT is now amending the promotion to revise the end date of the promotion from November 30, 2000 to December 31, 2000.
