(1) The measurement and billing of ISP traffic, including information service providers generally, Internet ISP traffic and traffic for those providers who sell access to the Internet, under the terms and conditions of the Interconnection Agreements by and between Ameritech and Time Warner Communications.

(2) Negotiations by and between Ameritech and Time Warner Communications concerning the treatment, measurement and billing of ISP traffic under the Interconnection Agreements.

(3) Ameritech's contention that "the Information Service Traffic location serves as a routing point to forward the call to the Internet," but such traffic does not terminate on the other party's network.

(4) The bases upon which Ameritech distinguishes or differentiates between calls to ISP customers on CLEC's networks and other local or business calls.


Ameritech shall chose one or more of its officers, agents, employees or other persons duly authorized to testify on its behalf, and shall set forth, for each person designated, the matters on which he or she will testify. The person or persons so designated shall testify as to matters known or reasonably available to Ameritech, including Ameritech Information Services.

Pursuant to O.A.C. 4901-1-20 and O.A.C. 4901-1-21(E), each person testifying on behalf of Ameritech shall produce for inspection and copying all documents used or referred to by the witness as to the matters on which he or she will testify in the deposition.


The deposition(s) will be taken as if on cross-examination and will continue from day to day until complete. You are invited to attend and participate.


