Dear Ms. Jenkins:

Cincinnati Bell Telephone Company (CBT) proposes to revise its **General Exchange Tariff** PUCO No. 8 Section 47 to provide a special promotion of its Complete Connections Service. **Residential** customers eligible for this promotion are new subscribers to Complete Connections or existing Complete Connections customers who have called to disconnect their Complete Connections Service but agree to keep the service. These customers will **pay the monthly recurring rate of \$29.99 for Complete Connections Service for the first three months**. The promotion period is February 9, 2004 through March 31, 2004.
