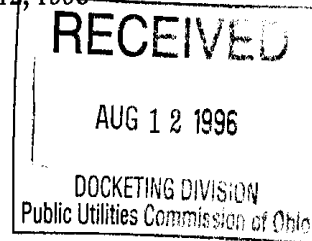

Dear Ms. Crockron:

Enclosed for filing is the original and 13 copies of revised tariff title sheets for PUCO No. 1, Message Toll Telephone Service Tariff; PUCO No. 1, Access Service Tariff; PUCO No. 1, Private Line Service Tariff; PUCO No. 5, General Exchange Tariff; and PUCO No. 6, Local Exchange Tariff of United Telephone Company of Ohio ("United"). The purpose for the revision is twofold. First, as the Commission is aware, United is a wholly owned subsidiary of Sprint Corporation. That fact is detailed in the revised tariff pages. Second, the revision notes that United may market the services outlined in these tariffs under the Sprint brand name.

The use of the Sprint name will not affect any rate, joint rate, toll, classification, charge, or rental, or any regulation or practice affecting same. Consequently, all regulated and tariffed services offered by United, under the brand name Sprint, will continue to be subject to the terms and conditions of these tariffs. This filing is similar to that approved by the Commission for Ameritech Ohio in Case No. 93-1252-TP-UNC (Finding and Order of January 6, 1994).



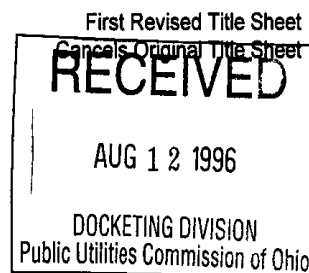
