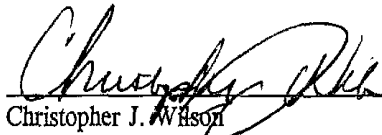

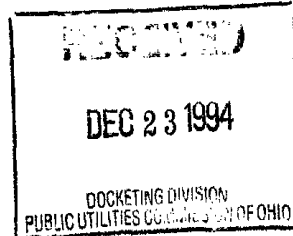

**ANSWER OF

Cincinnati Bell Telephone Company ("CBT"), by its attorneys and pursuant to the Public Utilities Commission of Ohio's ("PUCO") August 29, 1994 Entry, hereby answers the above-captioned petition as follows:

1. CBT is a telephone company and a public utility subject to the jurisdiction of the PUCO.

2. CBT owns and operates numerous telephone exchanges within the State of Ohio, including the Bethany, Bethel, Cincinnati, Clermont, Hamilton, Harrison, Little Miami, Newtonsville, Reily, Seven Mile, Shandon and Williamsburg exchanges.

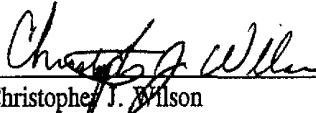
3. The low calling rates and distributions of calling from customers located in CBT's Bethany, Bethel, Cincinnati, Clermont, Hamilton, Harrison, Little Miami, Newtonsville, Reily, Seven Mile, Shandon and Williamsburg exchanges to customers in Ameritech Ohio's Monroe exchange clearly do not satisfy the Commission's rules as to the existence of a community of interest.

4. CBT denies each allegation in the Petition not specifically admitted herein to be true.

WHEREFORE, Cincinnati Bell Telephone Company, having fully Answered the Petition, requests that the Petition be dismissed.

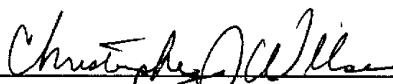
