Reasons for reallocation: The development straddles the territorial line between the utilities, but the companies can most efficiently serve these lots by slightly reallocating the territory and effectively trading two and one-half dozen lots.

Description of Reallocation: Relocate the boundary line which runs along the Montgomery-Warren County line so that DP&L will serve all lots located on Peebles Lane, Bloese Court, Haley Court and Burke Court, which would otherwise be in CG&E's territory and CG&E will serve all lots east of Settlers Walk Blvd. as far north as, and including residences on West Pugh and portions of Stanton Drive, which would otherwise be in DP&L's territory. Exhibit A is a details the proposal.

Are any affected customers aware of and in general agreement with the proposed reallocation? The Companies are already serving the affected customers as if the proposed territorial change is already effective.
