Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its General Exchange Tariff PUCO No. 8, and its Exchange Rate Tariff PUCO No. 3, to do a promotional offering of certain of its services. Also, Residence Service customers who subscribe to services listed above will receive a one month waiver of the monthly charge for adding any Custom Calling or Custom Calling PLUS service added at the same time that they order services included in the promotion.

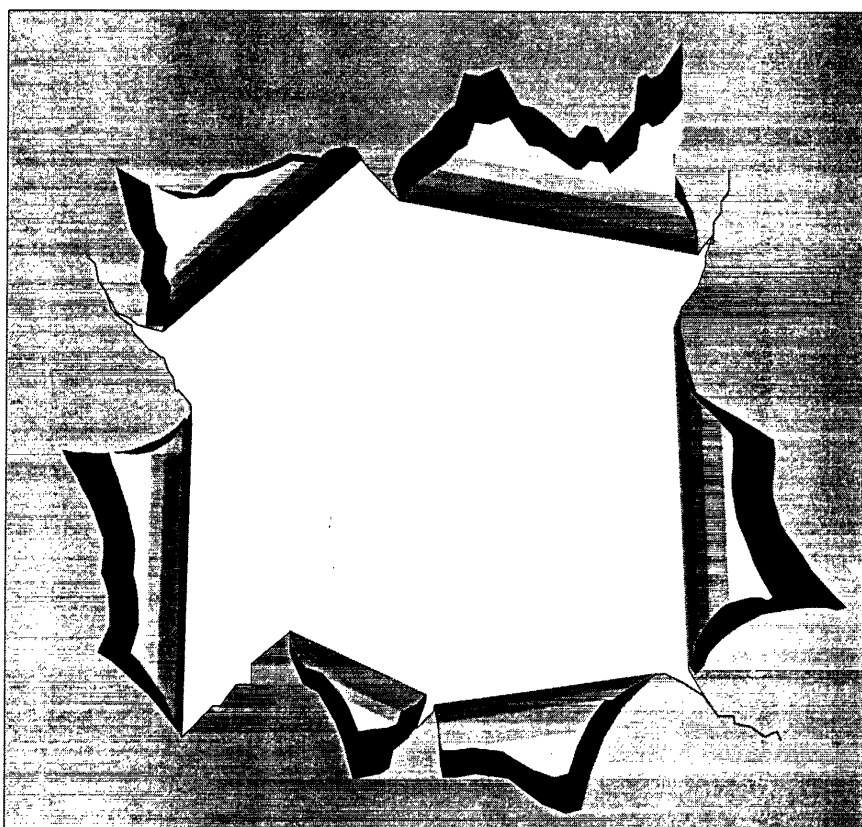
