The Commission finds:

- (1) Case No. 91-662-WW-ATA represents Ohio Water Service Company's (OWS) proposal to amend its Tariff provisions relating to the Related Facilities Charge.
- (2) Based on review and analysis of the proposal and after discussions with the Staff, OWS concluded that its proposed tariff modifications were unwieldy and would be difficult for customers to understand.
- (3) For the foregoing reasons, on February 3, 1993, OWS withdrew all of the filings made by it in this docket and requested dismissal of its Application, as modified by subsequent filings and proposals, and dismissal of this proceeding.
- (4) In this docket, Staff concurs with OWS' conclusion. The above captioned case docket requires no further Commission action and should be closed of record.

ORDERED, That the captioned case is hereby closed. It is, further,






