ENTRY

The Commission finds:

- (1) On April 28, 2000, Denzlee Fyffe (Complainant) filed a complaint against Columbus Southern Power Company (Company, Respondent) alleging that the Company overcharged him for electric service to his residence for the period September 1985 through August 1999.
- (2) Pursuant to Rule 4901-9-01, O.A.C., the Secretary of the Commission served a copy of the complaint on Respondent and directed Respondent to file an answer to the complaint, along with any responsive motion, with the Commission and serve a copy of the answer and any motion upon the Complainant.
- (3) By Entry dated May 2, 2000, the Attorney Examiner set this matter for a settlement conference to be held on May 17, 2000. The purpose of the settlement was to determine whether this matter could be informally resolved.
- (4) Complainant did not receive service of the Entry scheduling the settlement conference and, consequently did not attend. After conferring with the parties, the Attorney Examiner orally continued the settlement conference to May 22, 2000.
- (5) The parties met informally on May 19, 2000, at which time they resolved the issues that were the basis of this case.
- (6) On May 19, 2000, Complainant filed a "Withdrawal of Complaint and Request for Termination of Docket" (withdrawal notice). In support of his request, Complainant represents
