Dear Ms. Crockron:

On February 1, 2003 Cincinnati Bell Telephone Company (CBT) filed an application to conduct a business promotion. This promotion offered business customers, who subscribed to one of the Business Service Packages during the promotional period, a waiver of the nonrecurring charges associated with the Packages. This promotion is scheduled to end September 30, 2003.

CBT would like to request permission to make **two revisions to the Business Service Package promotion that waives the nonrecurring charges**. The first revision extends the ending date of the promotion to March 31, 2004. The second revision clarifies that this promotion is for new subscribers only. All other terms and conditions relating to the waiver of the nonrecurring charges which were established in the initial filing on February 1, 2003 will continue to apply.
