RE: CC Docket 99-200 – State Commission Role in Code Reclamation Process

Dear Ms. Tokarek:

Pursuant to your letter dated September 15, 2000, the Public Utilities Commission of Ohio (PUCO) is responding to your request to notify the North American Number Plan Administrator (NANPA or NeuStar) of the PUCO's intent to exercise jurisdiction over NXX code reclamation. The PUCO affirmatively accepts the responsibility to investigate and reclaim NXX codes from Ohio telephone code holders who do not place an NXX code "in service" within 6 months of the effective date of the assigned code.

As requested in your letter, the PUCO designates the following primary contact person for the coordination of all PUCO/NANPA activities regarding NXX code reclamation: Ms. Lori Sternisha, Utilities Specialist, Telecommunications Division (614 644-8036).

The PUCO anticipates that our staff's involvement in this process will lead to better utilization of numbering resources in the state of Ohio. The PUCO also expects that all code holders and NANPA will work cooperatively and reciprocally with our staff to ensure that this process is efficient and effective for all parties.

The PUCO is pleased that the Federal Communications Commission (FCC) has delegated this important authority to state commissions. We look forward to working with NANPA and the FCC to reclaim unused NXX codes so that they may be returned to the pool of available numbering resources for Ohio carriers and, ultimately, the Ohio consumers.
