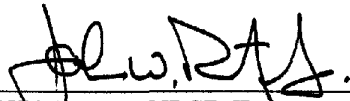

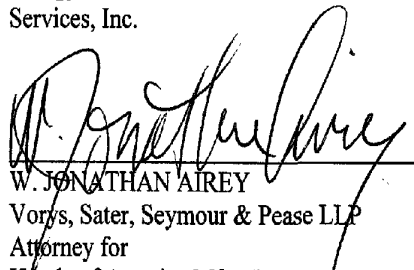
Dear Ms. Jenkins,

On May 5, 2004, the Public Utilities Commission of Ohio ("Commission") issued an Entry on Rehearing in the dockets listed above. The Entry on Rehearing accepted, with modifications, the 2003 Stipulation that the signatory parties docketed on October 9, 2003. 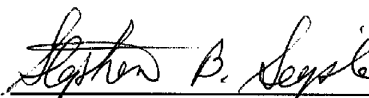
