The Commission finds:

- (1) On November 29, 1996, the complainant, Steven J. Longenecker, Eastland Telecommunications Consulting, Inc., (Eastland) filed a complaint with the Commission against Ameritech Ohio (Ameritech, or respondent). The complainant alleges that Ameritech had, in violation of its tariff, charged the complainant unlawful, unjust, and unreasonable charges.
- (2) A prehearing settlement conference was scheduled for, and then held in this matter on June 30, 1997.
- (3) The parties were able to arrive at a mutually satisfactory resolution of the issues presented in this case. On February 12, 1998, the parties, through counsel, jointly filed a motion seeking voluntary dismissal of this case, with prejudice.
- (4) The parties' February 12, 1998 joint motion for dismissal of this case, with prejudice, shall be granted.


