Customers utilizing DID must arrange to provide for interception of all unused telephone numbers in the groups of DID telephone numbers assigned by the Telephone Company.

Power Fault Protection is required where other company services are provided on facilities that extend to a high voltage environment, as determined by I.E.E.E. standards, requiring high voltage protection whenever hazardous voltage may appear on those facilities due to Ground Potential Rise (GPR) or induction caused by faults in the customer's electric power system.
