(2) Promotional Offer

Eligible customers, as described above, will receive a discount on the monthly rate associated with each of the Centrex services or Business Complete Connection packages and a waiver of the nonrecurring charges. The monthly rate will be \$50 for each Centrex line or business complete connections that the customer subscribes to. The \$50 will also include hunting and calling name and number. The customer will be required to sign a contract and early termination charge language will be included in the contract.
