Dear Ms. Crockron:

Cincinnati Bell Telephone Company (CBT) proposes to revise its General Exchange Tariff PUCO No. 8 in order to conduct a **promotion** which offers **residential customers a discount on the monthly rate associated with asymmetrical digital subscriber line (ADSL) service**. Customers served out of the Hyde Park Central Office who subscribe to ADSL during the promotional period and who produce a current copy of a competitors bill that contains billing for a service similar to ADSL, will receive ADSL service for a monthly rate of \$1.00 for the first two months of service. This promotion will be effective on August 24, 2002.

In accordance with the Commission's guidelines for promotions established in the cases referenced above, CBT is forwarding for filing three copies of the addendum sheets to the tariff pages affected by this promotion. Addendum sheets, in the form authorized by the Commission are being issued for CBT's General Exchange Tariff PUCO No. 8 Section 47, 4th Revised Page 1.11 and original page 77. The addendum sheets specify the terms and conditions that will be in effect for these services during the promotional period.
